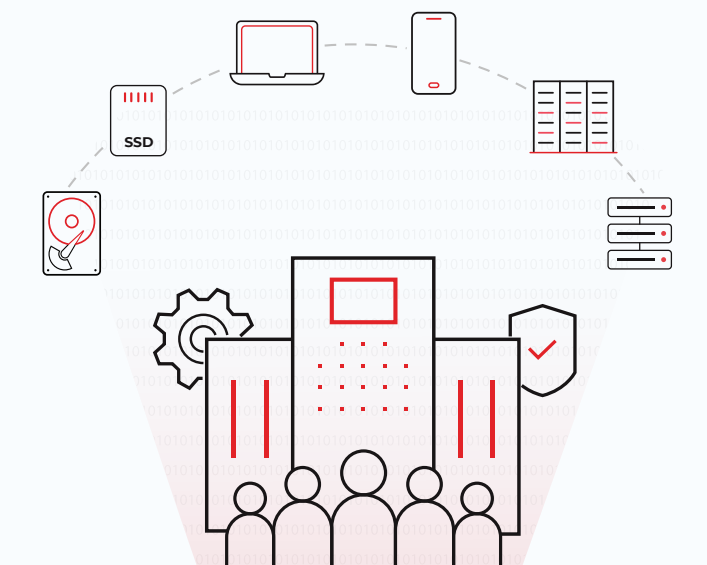


Media Sanitization for GDPR, CCPA, ISO 27001 & Others

Key Data Protection Regulations



EU-GDPR Regulation

Mandates personal data protection, secure erasure & user control over data.



ISO 27001 Guidelines

Requires secure disposal of sensitive information through media sanitization.



CMMC 2.0 Guidelines

Mandates strict data disposal practices for defense contractors handling FCI and CUI.

Consequences of Non-Compliance

Failure to securely erase data can lead to non-compliance with EU-GDPR, California's CCPA & CMMC 2.0, resulting in data breaches, financial penalties & reputation damage.

Sephora was fined \$1.2 Million for violating CCPA provisions by the Attorney General of California.

EU-GDPR Penalty

€20M

Fines can reach up to €20 million or 4% of annual global turnover for non-compliance.

CCPA PENALTY

\$7.5K

Businesses may face fines upto \$7500 per intentional violation & \$2500 per unintentional violation.
